Closing Date

- Entries to be received by 11 April 2009.

Payment

- Entries must be accompanied by the full payment. Entry forms will not be processed until the full payment has been received and cleared. Acceptable methods of payment are *Cash, Cheque, Money Order or Electronic Funds Transfer (EFT)*. (EFT information can be made available on request to IPSC (NT) Inc.)

Payment Periods

- Entry Forms RECEIVED on or after the payment periods that do not include the higher fees will be rejected and returned. Entry Forms will not be considered submitted until received with the correct fee.

Presentation Dinner

- Dinner tickets to be purchased in advance. No dinner tickets will be made available after the closing date.

Withdrawals

- Withdrawals prior to 1 February 2009 will be eligible for a refund less an administration fee of \$25.00. Withdrawals after 1 February 2009 will be eligible for a refund less an administration fee of \$50.00. Withdrawals after the closing date 11 April 2009 and failure to attend will result in forfeiture of all fees although should the match shirt have been purchased, this will be supplied.
